F Y I --The Following Races have UNIQUE CONDITIONS, Field is limited to top money earners that enter and refund of payments are a possibility so please read carefully.

AMERICAN NATIONAL for 3yo Races & Aged Races and THE WINDY CITY:

The race will be limited to the ten (10), Windy City eight (8), highest money winning horses in 2009 amongst those that enter as of the entry date for that race. USTA records (including currency conversions) shall be accepted as official. If more than ten (10) enter, Windy City (8), the horses not selected for the race will receive their 2009 payments back, UNLESS five (5) or more are not selected, in which case, they will race for a purse of \$20,000.

WORLD TROTTING DERBY-Open and Filly Divisions

The race will be limited to the ten (10) highest money winning horses in 2009 amongst those that enter as of Sept. 1, 2009. USTA records (including currency conversions) shall be accepted as official. If more than ten (10) enter, the horses not selected for the race will receive their 2009 payments back, UNLESS five (5) or more are not selected, in which case, they will race for a purse of \$25,000 (Fillies \$12,500) with no entry fee on the day of the race.

THE COLONIAL, THE BATTLE OF BRANDYWINE & THE VALLEY FORGE

Eight highest \$ earners in 2009 that enter will be drawn into Final, next 8 highest will be Consol. 1, next 8 highest will be Consol. #2. If your horse is entered and meets racetrack's qualifying standards but is not one of the 24 "selected" horse or a Consol. doesn't fill then the 2 SUSTAINING Payments will be refunded. This EXCLUDES the Nomination Payment of February 15, 2009.
