ELIGIBILITY CONDITIONS FOR NOMINATION: Each Colt or Filly must be Sired by a stallion registered with the Kentucky Standardbred Development fund; A 2 or 3 yr old whose dam was partially or wholly owned by resident of Ky. at time of conception; or a 2 or 3 yr, old owned or partially owned by a Ky. resident at time of nomination and remain Ky. owner entire fair season. ALSO All owners must be a current member of the Kentucky Colt Racing Association AND All owners, trainers, and drivers must hold a current license with the KY Racing Commission.

DATES FOR 2016-(these are subject to change) if there are more than 70 horses entered in any one fair that fair will race on two days. If less than 70 the 1st date listed will be the race date.

Ballard Co (LaCenter) June 13 / 14; Purchase Dist (Mayfield) June 6 / 7; McCracken Co (Paducah) June 20 / 21; Marion Co. (Lebanon) June 28 / 29; Washington Co (Lebanon) July 5 / 6; Woodford Co. (Lebanon) July 15 / 16; Mercer Co. (Red Mile) July 22 ;
Finals (Red Mile) July 30. **Purses \$4000, \$2000 if Split Once, \$1333 if Split Twice. Finals \$10,000 Est.**

Nominations Close February 15, 2016 --- Nom. Fee \$50 per Horse, Sustaining Payment Due April 15, 2015 for \$200 per Horse.

Entry Fee \$50 per Fair and \$200 for Finals. Must start in at least 4 Fairs to be considered for Final eligibility.
