## KY FAIRS -- NEW CONDITIONS FOR 2015

Nominations Close February 15, 2015 --- Nom. Fee \$50 per Horse

The new 2015 eligibilty rules have passed the Racing Commission and LRC. the The new rules read as follows: Eligibility: A horse is eligible to participate in a stake race at a county fair if (1) the horse is a two or three year old that is sired by a stallion that was registered with the Ky. Standardbred Development Fund at the time of conception (2) A two or three year old whose dam was partially or wholly owned by an individual or person domiciled in Kentucky at the time of conception (3) A two or three year old that is owned by an individual or person domiciled in Kentucky. (4) An owner is a current member of the Kentucky Colt Racing Association and (5) All owners, trainers, and drivers must hold a current license with the KY Racing Commission. ALSO All owners must be a current member of the Kentucky Colt Racing Association AND All owners, trainers, and drivers must hold a current license with the KY Racing Commission.
