For 2-year-old pacing fillies in 2017 that are registered with Standardbred Canada or the United States Trotting Association prior to the date on which nominations close (May 15, 2017) and are (a) sired by a stallion that stood in Canada for the entire 2014 breeding season, OR (b) non-Canadian sired fillies that are wholly owned by residents or citizens of Canada from the time of nomination (May 15, 2017) provided that: (i) if the owner is a partnership, stable, corporation or a similar entry, all partners, members or shareholders must be residents or citizens of Canada; (ii) if leased, both lessor(s) and lessee(s) must be residents or citizens of Canada; (iii) to remain eligible to either event, fillies must continue to be wholly owned by residents or citizens of Canada at the time the event is contested; (iv) the sale of a nominated filly to a non-resident or non-citizen of Canada eliminates it from further eligibility as of the date of the sale, and (v) all sales of nominees both before and after nominations must be bona fide sales. For the purpose of these conditions, "residents of Canada" are persons who maintain their permanent residences in Canada at the time nominations close and resided in Canada for at least 183 days in 2016. "Citizens of Canada" are persons who maintain their Canadian citizenships.
